As stated above the Annual Results for the previous year ended on March 31, 2021 and all results prior to 01.04.21 does not include Ind AS compliant pursuant to the exemption granted in SEBI's Circular CIR/CFD/MD/15/2015 dated 30th November 2015 modified to comply with the requirements of SEBI's circular dated 5th July 2016, Ind AS and Schedule III Division II to the Companies Act, 2013.
